



ExSilent USA, LLC Website Terms of Use

ExSilent USA, LLC (“ExSilent”) operates the website www.exsilent.com/us (the “Site”). The Site provides online access to information about us and the products available through the Site (the “Products”). It also facilitates transactions for the purchase of Products (the “Service”). The terms “we,” “us” and “our” as used herein refer to ExSilent.

By accessing and using the Site, including the creation and use of an Account (defined below), you agree to each of the following terms and conditions (“Terms of Use”). By using the Site and/or Service or ordering Products from our Site, you agree to the Terms of Use, as well as the [Terms and Conditions of Sale](#). These Terms of Use, together with the Terms and Conditions of Sale, are referred to as this “Agreement”.
